- Restricted stock units and dividend equivalent units, which vest on the earlier of (i) June 7, 2014 and (ii) the first annual meeting of the Issuer after June 7, 2013.
- This amendment to Form 4 reflects that the reporting person was awarded 1,038.7664 restricted stock units and dividend equivalent units by the Issuer on September 27, 2013, rather than 1,133.2074.
- An option which vests on the earlier of (i) June 7, 2014 and (ii) the first annual meeting of stockholders of the Issuer after June 7, 2013.
